US Forest Service Minerals Policy Review

As prospecting season approaches, we must remember that some GPOC claims are on US Forest Service (USFS) public lands. For those seasoned prospectors among us, you know that we are both prospectors and shepherds of the land—we must return our public lands to their native state once we extract values (i.e. gold and other precious metals) from the

To that end, let's review the US Forest Service definition of minerals and the policy on minerals and geology. Our public lands are available for us to prospect (as long as they are not already under claim!). We should take advantage of that respectfully and regularly. Get out there and enjoy...and bring home some of that yeller gold! The US Forest Service defines a mineral as: "a naturally occurring substance (as ore, petroleum, or water) obtained usually from the ground".

The USFS Minerals Management program guides us as prospectors in being land shepherds. The USFS "chief goals are to restore ecosystems and watersheds affected by past mining practices; to provide the geologic expertise and scientific information necessary for sustained forest manage-

ment and for watershed health and restoration: to manage and protect paleontological resources; and to manage the vast and diverse mineral resources of the national forest in a fashion that ensures sustained ecosystems and maintains


healthy watersheds. Exploration, development, and production of mineral and energy resources and reclamation of activities are part of the Forest Service ecosystem management responsibility. The Forest Service will administer its minerals program to provide commodities for current and future generations commensurate with the need to sustain the long term health and biological diversity of ecosystems."

The Federal Government's policy for minerals resource management is expressed in the Mining and Minerals Policy Act of 1970, "foster and encourage private enterprise in the de-

> velopment of economically sound and stable industries, and in the orderly and economic development of domestic resources to help assure satisfaction of industrial, security, and environmental needs." Within this context, the National Forests and Grasslands have an essential role in contrib-

uting to an adequate and stable supply of mineral and energy resources while continuing to sustain the land's productivity for other uses and it's capability to support biodiversity goals.

energy resources and reclamation of activities are part of the Forest Service ecosystem management responsibility. The Forest Service will administer its minerals program to provide commodities for current and future generations commensurate with the need to sustain the long term health and biological diversity of ecosystems. Accordingly, the Forest Service will strive to:

- Ensure that exploration, development, and production of mineral and energy resources are conducted in an environmentally sensitive manner and that these activities are integrated with the planning and management of other resources using the principles of ecosystem management.
- Facilitate the orderly exploration, development, and production of mineral and energy resources within the National Forest System on lands open to these activities or on withdrawn lands consistent with valid existing rights.

- Maintain opportunities to access mineral and energy resources which are important to sustain viable rural economies and to contribute to the national defense and economic growth.
- Ensure that lands disturbed by mineral and energy activities, both past and present, are reclaimed using the best scientific knowledge and principles and returned to other productive uses.

administer its minerals program within the overall context of the principles of ecosystem management. Accordingly, the Forest Service will:

- Ensure that mineral-related activities are in accordance with our legal and regulatory authority.
- Coordinate and cooperate with other Federal and State agencies having authority and expertise in mineral-related activities.

- Coordinate and cooperate in a collaborative manner with interested public, industry, and community representatives. Foster partnerships with industry to increase knowledge of development potential of the mineral estate.
 - Ensure the integration of mineral resource programs and activities with the planning and management of renewable resources through the land and resource management planning process, recognizing that mineral development may occur concurrently or sequentially with other resource uses.
- Maintain an effective professional, technical, and managerial work force that is knowledgeable of (a) the geologic characteristics of mineral deposits, (b) the techniques of mineral exploration and development, (c) the principles of ecosystem management, and (d) mineral laws, regulations, policy, and guidance.
